1. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

## 2. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. Bidders are required to refer the complete bid evaluation criteria (BEC), evaluation methodology and the detailed tender document as uploaded at buyer uploaded ATC document.
2. **On GeM portal, in custom bid for services functionality, bidders must quote total lumpsum price including GST. Therefore, the total lumpsum price including GST considering all SOR items, their respective total qty, buy-back value excl of GST for buy-back of existing old systems and all other cost elements as per tender as calculated in SOR/BOQ/Financial Document (Price breakup) is to be quoted on GeM portal and confirmation to this effect is to be submitted in format F-5 (Agreed Terms and Conditions). Bidders not complying to these notes, their bid shall be liable for rejection.**
3. **All bidders must note that instant requirement being Works tender, EXEMPTION of EMD/BID SECURITY to MSEs is not applicable. Even MSE bidders are required to submit the applicable EMD/Bid Security. Bidders must also note that bids having insufficient EMD/bid security is liable for rejection.**
4. **The applicable % of CPS is 10% of total contract value for new systems excl of GST which shall supersede the % specified on GeM bid document which was mentioned as 5% due to system constraint.**
5. Bidders are required to upload documents in compliance of the tender terms and conditions including but not limited to the following
  - i. Documents related to BEC with due authentication as mentioned at Section-II of the tender.
  - ii. Documents related to appropriate form of EMD/Bid security.
  - iii. Copies of PAN & GST registrations.
  - iv. Duly filled, signed & stamped forms and formats of tender documents **(F-1, F-2A, F-5, F-7, F-8, F-9 (if applicable), F-10 & F-12)**
  - v. Copy of Power of Attorney (**PoA**) in the name of the person who will

be signing the bid documents on behalf of bidding firm.

- vi. Bidder's undertaking in the prescribed format **Form-IA, Form-IB & Form-II to Section-II** of the tender document regarding self declaration of bidder that they are not operating from a country which Shares a Land border with India.
- vii. Original Documents of Form of EMD/bid security and Line of Credit (if applicable) from bank in case of inadequate working capital are to be submitted by post/courier to the address mentioned in the tender.

**6.** Wherever any portion of the tender terms as uploaded at buyer uploaded ATC document is repugnant to or at variance with any provision[s] of the "GeM GTC", the provisions of the tender terms as uploaded at buyer uploaded ATC document shall be deemed to override the provisions of "GeM GTC". In case of any contradiction, the decision of the "buyer" will be final and binding on the bidders.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the

case may be.

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
