### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.
- Copy of EFT Mandate duly certified by Bank.

### 3. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

### 4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- Inspection clause: PDI at vendor#s works by NTPC/NSPCL representative as per approved QP.
- Guarantee/ warranty Clause: 18 Months from the date of supply and acceptance of the materials by NSP CL or 12 months from the date of successful retrofitting and commissioning whichever is earlier.
- PBG Clause: Applicable @ 5%. (PBG is applicable as per present prevailing rules).
- Fitment Guarantee: Applicable.
- Documents required with Bid for Bid evaluation: Vendors are requested to submit Techno-commercial offer along with endorsed "Nil-Deviation certificate, tender document and SPC".
- Documents required along with material Supply:

a). Guarantee/ warranty certificate.

b). Test Certificates as per scope of work.

7. Drawing and QP Approval: Applicable. The party must submit detailed drawings of the breaker & Manufacturing quality plan (MQP) for approval of NSPCL, before

manufacturing of the same.

8. Payment Terms:

Supply Items:

a) 95% of supply component amount will be released after receipt & acceptance of material at NSPCL stores.

b) Remaining 5% of supply component will be released after completion of defect liability period /submission of PBG.

Retrofitting:

a) 95% of retrofitting charges will be paid after successful retrofitting & commissioning against RA Bills duly certified by EIC.

b) Remaining 5% of retrofitting component will be released after completion of defect liability period/ submission of PBG.

9. Delivery period and Schedule: Delivery to be completed within 5-6 months from award.

10. Bid Evaluation Criteria: Bid Evaluation shall be done package wise.

11. Special Instructions:

a) Items to be quoted strictly, as per Item long text.

b) Any deviations in material specifications have to be clarified prior to bid submission, any clarifications post bid opening will not be acceptable.

c) Vendors have to mention the Make & model/CAT NO. against respective item.

d) Only direct offers from Siemens Limited (OEM) shall be entertained. Offers from authorized system houses, dealers or channel partners shall be summarily rejected and not

entertained. The order shall be executed by Siemens Limited directly and testing and commissioning at site shall be done directly by Siemens engineer.

Special Instruction-:

1) The Circuit Breaker should be drawable and mounted on wheeled truck with one to one replacement in place of existing circuit breakers

2) TYPE TESTS

Type test certificates, as per IEC 62271-100, for the following type tests shall be required on 1000 A or higher and 6.6 KV or higher rating of breakers and are to be submitted at

the time of inspection for review.

. Type tests should have been either conducted at an independent laboratory or should have been witnessed by a client.

a) Lightning Impulse Voltage withstand tests

b) Dry Power Frequency Voltage withstand tests

c) Short time withstand current & peak withstand current test

d) Temperature rise test

If the party does not have any of the above type test certificate, then the required test shall be carried out

by the party in any of the NABL accredited laboratory at no extra cost to NSPCL.

### 3. ROUTINE TESTS

Following routine tests shall be required on supplied breakers:

- a) Dielectric test on main circuit as per IEC 62271-100 clause 7.1
- b) Tests on auxiliary & control circuit as per IEC 62271-100 clause 7.2
- c) Measurement of resistance of main circuit as per IEC 62271-100 clause 7.3
- d) Design & visual check as per IEC 62271-100 clause 7.5
- e) Mechanical operating test as per IEC 62271-100 clause 7.101

4. All the retrofitting material including TBs, wires & indicating lamps etc. which are required for successful retrofitting is in vendor's scope.

5. The party must submit detailed drawings of the breaker & Manufacturing quality plan (MQP) for approval of NSPCL, before manufacturing of the same.

6. Retrofitting of these breakers will be carried out in maximum of 3phases. Party has to deploy qualified manpower for carrying retrofitting job. Necessary arrangement for stay at

Bhilai, to & fro Transportation is in the scope of bidder. No additional charges will be paid.

### **Bidders Participation Criteria**

1) This Tender is reserved for OEM M/s SIEMENS LIMITED or their respective channel partner/authorised dealer only.

2) Authorized dealer/Channel Partner of OEM may participate in the bid provided they have the valid Bid Specific authorization from the OEM for the particular tender. Authorized dealer / Channel Partner shall attach the Bid Specific Authorization Certificate / Confirmation from the OEM along with the bid documents as proof of authorization.

3) Bid submitted by vendor other than OEM / Channel Partner/ Authorized dealer shall be liable for rejection.

**Note:** Additional Specifications, Buyer Added Bid Specific Terms & Conditions & Attachments (if any) alongwith Tender Specification shall be deemed unconditionally accepted by seller, unless there are specific representation/s or clarification/s prior to bid submission in GeM Portal.
