2. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

2. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior

written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

4. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. **Payment**

PAYMENT OF SALARIES AND WAGES: Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

7. **Past Project Experience**

Proof for Past Experience and Project Experience clause: For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. Contract copy along with Invoice(s) with self-certification by the bidder that service/supplies against the invoices have been executed.b. Execution certificate by client with contract value.c. 1. Our organization works on important government printing works for Elections, Budget, Lock Bhavan, Chief Minister's Office, Gujarat Legislative Assembly and various Gujarat Government. So sometimes we need to work for extra hours hence it is mandatory for the bidder to have staff present on ev

ery extra working day including public holidays and extra working hours as per the prior requirement of the organization.

2. The buyer reserves the right to extend or terminate the service of the contract period at any time after award of contract.
3. Technical evaluation will be based on the documents submitted by the bidder along with the bid. During the technical evaluation process, clarifications will be sought for only the submitted documents. No new documents will be submitted.
4. EMD exemption will be given as per clause no. 4(A) of Gujarat State Procurement Policy-2024.
5. In case grant is not available with the nodal agency, payment may be delayed and payment will be made through the government PFMS portal.
6. Payment of Salary and Wages: The Service Provider shall first pay the salary/wages of the contracted staff deployed at the Buyer's location i.e. by himself and then claim the payment from the Buyer along with all legal documents like PF, ESIC, Pay Slip etc. as well as bank statement of payment made to the staff.
7. Geographical Presence of the Service Provider: Should be registered in (any one of) the following districts namely Gandhinagar, Ahmedabad, Mehsana, Sabarkantha and Aravalli districts. The head office or branch of the bidder should be located in Ahmedabad or Gandhinagar. The bidder will have to submit documentary evidence (Municipal Tax, Electricity Bill, Landline Bill) in the name of the firm. Bidders not having office/branch in Ahmedabad/Gandhinagar will not be eligible for technical bid and will be rejected immediately.
8. Self-certification on letterhead that the bidder has not been debarred/blacklisted by any Central/State Government Institution or Organization in the last 5 years (Bid should not be older than six months from the date of publication.)
9. GST Registration Certificate must be uploaded.
10. ISO Certificate must be uploaded.
11. Bidder Turnover Criteria: The minimum average annual financial turnover of the bidder during the last three years ending on 31st March of the previous financial year should be as mentioned in the bid document. Certified audited balance sheet of the relevant period showing the turnover details for the relevant period or a certificate from a Chartered Accountant / Cost Accountant shall be uploaded along with the bid. 12. Payment will be made only after satisfactory completion of the required services at our office/institution.
13. PF/ESI certificate must be uploaded.
14. The bidder will have to submit a certificate of financial standing. (Bid should

d not be older than six months from the date of publication.)

15. Minimum three years of experience in Government Offices is required, proof of good performance of Manpower work by Government Office should be submitted. (Copy of Gem Contract will not be accepted.)
16. If any of the mentioned certificates/details are not furnished by the bidder, then the bidder will be disqualified from bidding.
17. The jurisdiction for the resolution of any legal dispute shall be the District Court, Gandhinagar, Gujarat and the decision of the court shall be final.
18. It is mandatory for the bidder to submit ANNEXURE -1 for compliance with all the conditions of ATC and ANNEXURE -2 for geographical presence of the service provider. Bidders who do not submit ANNEXURE 1 & 2 will be disqualified.
19. It is mandatory for the bidder to sign and stamp all the documents submitted by them. No other documents (no repetition of the same document) other than the required documents should be submitted, the first document will be considered valid and the technical evaluation process will be carried out, the document submitted a second time will not be taken into consideration.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
