its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 9. A) Technical Specification of Procurement of Water Washable Digital Nylo Printing Plates

Water Washable Digital Nylo Printing Plate (755 X 840 X 0.73mm)

1. Water Washable Digital Nylo plate compatible for developing with Wash-out System. Further these developed plates with fine and high security designs should perform in KBA & Komori dry offset printing machines at the speed of 10000 sheets/hour.
2. Plate Size: 755 mm x 840 mm
3. Plate should have steel base with overall uniform thickness of 0.73 mm (Steel base 0.27mm & Polymer 0.46 mm)
4. The plate shall consist of light sensitive photopolymer material firmly bonded to base steel material.
5. Nylo Plates should be suitable for producing high resolution offset designs of 10,160 dpi and above.
6. Plate should be suitable for fine text and very fine security design having precise details.
7. There should not be any data loss during plate reproduction and printing.
8. Dimensional stability of the plate should be very high.
9. Plate should produce excellent solid density during printing.
10. Plate shall be washable in water only during developing.
11. Plate hardness : 77 Shore 'D'
12. The digital photopolymer plate should have proper visibility for examination after developing to differentiate the relief area and base plate.
13. Plate should be suitable in Jura Seculas CTP and compatible with Flint Group Nyloprint Exposure F III m

achine & Flint Group Nyloprint Wash-out System.

14. Plates should be capable of laser diode exposing in Jura Seculas CTP machine.

15. Plates should be free from oil and greasy substances on the light sensitive coating. It should not be Sticky to prevent clogging of laser head, pipe lines and filter of dust collector system in CTP machine. There should not be any rust formation on the bare metal surface.

16. After drying & post exposure, the plates shall have very good resistance to the wear and tear and image breaking.

17. The unserviceable plates should be suitable to be defaced by hot water by peeling off the polymer coating easily.

18. Waste water produced during processing of the plates should be environment friendly.

19. Packing should be robust enough to withstand the pressure during handling and transportation.

20. Corners of the plate should not bend while mounting on the plate cylinder.

21. Shelf life of the plate should be minimum two years from the date of delivery.

B) Other Term & Conditions

1. The supplier should enclose certificate from the manufacturer that the plate is suitable for reproducing image having resolution of 10160 dpi.

2. Plate should be supplied in the original packing of the manufacture and should be sufficient to protect from light exposure and water. One box should contain 10 plates only.

3. The packing should be duly labeled with complete description of the product inside along with manufacturing date.

4. The supplier should enclose warranty certificate, MSDS certificate/Safety Data Sheet.

5. If any rejection, the supplied Nylo plates will not be returned back to the supplier.

C) Delivery Schedule

The bidder must have an annual capacity to supply at least 152 Nos. of Water Washable Digital Nylo Printing Plates.

Note: All experience, past performance and capacity/ capability related data should be certified by the authorized signatory of the bidder firm.

3. Financial Standing:

(a) The average annual financial turnover of the bidder firm (Manufacturer of Principal of authorized dealer) during the last three years, ending on 31st March 2025, should be more than Rs. 10,94,096/- as per the annual report (audited balance sheet and profit & loss account) of the relevant period duly authenticated by a chartered accountant/Cost accountant in India.

(b) The Net Worth of the firm should:

- i) Not be negative on 31st March 2025 and
