7. **Warranty**

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. 2. The OEM should be LPPM (London Platinum and Palladium Market) accredited platinum refiner. Certificate in this regard to be provided along with the bid.
3. Manufacturer must have commercially supplied platinum crucible/ mould to at least two purchasers (reputed purchasers / Gol/ PSU/ Gol funded Institute/ State Govt.s/ State funded Institutes) in India in last 5 years (as on date of opening of tender). 2. Weight and Dimensional metrology of supplied item will be performed at purchaser's site.
3. The item will be accepted only if the elemental impurities are within the limits as per specifications in Section B.
