1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. 3. Buyer has allowed part quantity bidding, bidders can offer maximum quantity that they can deliver keeping in mind their capacity and delivery period requirements. The offer quantity has to be more than minimum bid quantity as specified by the Buyer in the bid. Offers with quantity less than Minimum are liable to be rejected. It may however be noted that there is no guarantee that full offer quantity will be ordered by the buyer. Qualifying Requirement of the Bidder 4.1 This invitation for bid is open to all company/LLP incorporated in India under Companies Act, 1956 and Companies Act 2013, Proprietorship firm and includes Government owned Enterprises and does not includes foreign bidders/MNCs not registered and incorporated in India and those companies with whom business is banned by the Owner. The Qualification of bidder will be based on meeting the minimum pass/fail criteria specified below on standalone basis. 4.2 Technical Qualifying Requi

rement: Unless otherwise specifically mentioned in the Bid Data Sheet (BDS), the bidder should have following Technical Qualifying requirement; a. Bidder should be a company/LLP registered under companies Act 1956/2013 & Proprietorship firm . Manufacturer Base: The Bidder should be a manufacturer of the tendered equipment / materials and should have its own manufacturing facilities in INDIA. b. Minimum Offer Quantity: The minimum quantity to be offered by the bidder shall not be less than 50% of the tender quantity for any of the Substation Supply items and not less than 30% of the tender quantity for any of the Line Supply Items. If the quantity offered by the bidder is less than 50%/30%, their bid shall be rejected out rightly. c . d. e. f. g. Supply Experience: The Bidder shall demonstrate that it has successfully supplied the Equipment/Materials of same or higher standard/size of at least 100% of the quantity offered in the tender to any Transmission/ Generation/Distribution Utility in any State/Central/ or any CPSU/PSU or any Transmission Licensee awarded with Transmission Project under Tariff Based Competitive Bidding (TBCB) process in India during last 5(Five) years reckoned from the Original schedule date of submission of bid, so as to meet the Supply Experience qualifying criteria. However, if the company exists for less than five years, it shall demonstrate minimum supply experience of 20% of the quantity offered per year of existence within one to four years. Operational Experience: The Offered equipment/materials should have at least one year proven trouble free operational service in tropical climate as on Original schedule date of Bid opening. The bidder shall furnish evidence in the form of certificate from Power utilities that the equipment/materials supplied by them have been performing satisfactorily. The bid shall be accompanied by user's performance certificate from Transmission/ Generation Utility in any State/Central/ or any CPSU/PSU or any Transmission Licensee awarded with Transmission Project under Tariff Based Competitive Bidding (TBCB) process in India in support of satisfactory performance of their above equipment/materials supplied earlier. Testing Facility: The Bidder must have all necessary testing facilities at their own factory for carrying out routine and acceptance tests as prescribed in the relevant ISS and any other test as specified in the technical specification (Volume -II). Type Test Requirement: The equipment/materials shall have Valid Type Test Report conducted at the Accredited Laboratory of repute such as CPRI/EREDA/ NABL Accredited Labs. Such Type of Test Reports (TT Rs) shall remain valid for the period mentioned in the CEA Guidelines as adopted by UPPTCL from time to time reckoned from the original date of opening. Bids not accompanied with type test reports conducted during the period mention in of BDS of the offered Equipment/Materials duly approved by the Type Testing Agency shall not be considered for evaluation. The type test report of their principal can also be accepted subject to the guarantee period of 54 months form date of supply or 48 months from date of commissioning whichever is earlier. Guaranteed Technical Particulars: The Equipment/Materials shall meet the minimum guaranteed Technical Particulars specified in the Volume-II of this tender.

4.3 Financial Qualifying Requirement: Unless otherwise specifically mentioned in the Bid Data Sheet (BDS), the bidder should have following Financial Qualifying requirement; a. b. c.

4.4 a. b. ii. Turnover: The Minimum Average Annual Turnover (MAAT) of the Bidder shall be at least 2 times of the estimated cost of the tender. In case the bidder offers the minimum quantity, the MAAT of the bidder shall be reduced to that extent. For the purpose of calculation of MAAT, Average of the Best Three Financial Years Turnover out of the Last Five Financial Years preceding to the year of NIT shall be considered. In case the Bidder is in existence for less than five financial years the Minimum Average Annual Turnover shall be average of the turnover of the completed no of financial years. The turnover of the bidding company shall be on standalone basis only (excluding its Associate companies /Holding Company) duly certified by the Chartered Accountant/Cost Accountant firm.

Bid Capacity: The bidder shall be eligible for opening of the Price Bid based on the available bid capacity defined as under; Available bid capacity = $[(2 \times A) - (0.5 \times B) - C]$, should be equal to or more than the tendered estimated price . where , A = Highest Project Related Annual Turnover of the Bidder on Standalone Basis (excluding it's Associated Companies/ Holding Company as the case may be) in any financial year during last three financial years. B = Total Order Value of Ongoing Work /LOAs placed by UPPTCL and Other Organizations on the Bidder on the date of opening of the Technical bid and not executed on the date of opening of the technical bid. C = Package(s)/Works finalized but yet to be awarded in favor of the Bidder by UPPTCL. Note: In respect of (B) & (C) above for Joint Venture/ Consortium, share of each partner would be as per agreed profit/work sharing ratio in the Joint Venture /Consortium Agreement. In absence of the same, it would be considered as equal sharing.

Insolvency Position: The bidder must not have been declared Insolvent and their cases have not been referred to National Company Law Tribunal (NCLT). In such a case the bid is liable to be rejected. In this respect bidder shall submit an undertaking towards its insolvency position. Certificate/Affidavit : Unless otherwise specifically mentioned in the Bid Data Sheet (BDS), the bidder should submit the affidavits /undertaking in respect of;

Documents: The bidder must upload the signed documents in support of the above Technical and Financial criteria as per the prescribed format.

Legal Dispute: i. The bidder(s) should not have any pending litigation with UPPTCL with regard to any project or related activity. The bidder should certify/ declare the same in unequivocal terms by way of an affidavit duly sworn before a Magistrate/ Notary. Bid furnished by the bidder shall not be eligible for consideration if it is not accompanied by the Affidavit.

Blacklisting/Debar The bidder(s) shall also disclose if he was black listed/ Debar by any utility of central / state/PSUs or any Government department in the past and the blacklisting order was subsequently withdrawn by the utility suo-moto or set aside by any court order. Detection of the bidder's non-disclosure of these facts at any stage will lead to rejection of the bid or termination of the contract with forfeiture of EMD/ CPBG.

c. Acceptance of Technical & Commercial Conditions of the Tender: The bidder must agree to the guar

anteed technical parameters specified in Volume-II and shall also accept the commercial terms and conditions of the tender without any deviations. d. e. f. The bidder must fulfill the e-tendering process guidelines. The bidder must furnish Affidavit in the prescribed format to the effect that the documents and information furnished by them in its bid offer in respect of the said tender are true and correct. The bidder must submit the qualification data, information and documents incomplete shape as per the prescribed guidelines of the official e-tender portal of the Owner.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
