If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. 5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

9. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

10. Short Duration Bid has been published by the Buyer with the approval of the Competent authority due to Emergency procurement of critical products/services.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Service & Support

The Service Provider is required to have at least 40 % of the required manpower on service provider's

payroll for at least one year. Necessary documents relating to such manpower will be uploaded by the bidder for verification of the buyer. Such manpower will be part of total manpower to be provided by the Service Provider in case he gets the contract against this bid.

3. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. **The following documents are required to be submitted :-**

- (a) EPIF registration certificate.
- (b) ESI registration certificate.
- (c) Undertaking certificate for minimum wage.
- (d) Copy of valid license issued by commissioner competent authority (Regulation and abolitions act - 1970).
- (e) The numbers of Chowkidar hired per day i.e 10 and numbers of days of hiring per month i.e are subject to change as per work load. Both of these parameters can reduce but shall never include.
- (f) Service charge as applied rate calculation should be minimum 3.85% & not below in any case.
- (g) Registration of Firm/Agency/Company experience certificate minimum three years.
- (h) Attested copy of PAN Card.
- (j) Labour License issued by Central Labour Commissioner.
- (k) The Firm should have one year's experience with State/Central Govt Agencies for providing outsourcing conservancy.
- (l) Prof of Challan copies of EPF & ESIC deposited in Govt treasury in last one year.
- (m) Details of amount of average business turnover of the contractor not less than 10 lakhs for the last three years.
- (n) Copies of Income Tax Return (ITR) Form for the last assessment year.
- (o) GST Registration Certificate.
- (p) Bank solvency Certificate with minimum 10 lakhs in favour of tender issuing authority from scheduled bank.
- (q) Labour Cess duly paid average not less than amounting to 5 lakhs of last two years.
- (r) Electronic Clearing Services (ECS) Mandate Form issued by Scheduled Bank.
- (s) Affidavit of firm for Not Blacklisted/Terminated.
- (t) Affidavit for genuineness of documents with undertaking regarding no forged documents enclosed.

2. **Rejection Clause.**

- (a) The bidders of the firms quoting unreasonable low rates will not be entertained and may be delisted from the given range of the service.
- (b) An individual/ firm submitted more than one bid will be summarily liable to be rejected.
- (c) Conditional bids will not be considered and outrightly rejected at the very first chance.
- (d) Subletting of the contract.
- (e) Unreasonably low, nil or negative quote for profit per person per day shall be unresponsive and will not be evaluated for this contract.
- (f) Convassing by bidder in any form, unsolicited letters and post bid corrections any invoke summarily

y rejection with forfeiture of e-PBG. Conditional tenders will be rejected.

(g) Officer Commanding 481 (I) Sup PI ASC Samba reserves all rights to rejected bids any stage without assigning any reasons thereof.

3. **Mandatory Clauses.**

(a) Pre-bid meeting is a mandatory clause bidder are requested to attend pre bid meeting.

(b) Bidder are to submit of MSME certificate of bid category.

(C) Bidder are to submit bank solvency certificate of Rs 30,00,000/-.

(d) The bidder to ensure demanded manpower will report at this office/ unit 0800 on the day of employment.

(e) Demand of semi-skilled Chowkidar will be as per the requirement in the unit.

(f) The bidder will carryout skill test of the candidate provided by vendor/ dealer. Certificate to that effect will be submitted to this office in advance. If candidate is not fit/ Skilled for the duties, replacement will be provided immediately.

(g) The employment is not for fixed for any duration.

(h) Number of working day may vary depending on security situation and requirement of work in the unit.

(j) The hiring of individual will be done by this unit on requirement basis.

(k) The bidder has to furnish certificate that he will not disclose any information to any unauthorized person. He will not be allowed to use smartphone inside the unit premises. He will be in possession of I-Card issued by the firm/ Vendor.

(m) Pre-bid meeting. Pre bid meeting is mandatory clause. Bidder are requested to attend pre bid meeting.

(n) Effective date. The contract shall be effective from the date as stipulated in the letter of award.

(o) The contract may be extended for the duration of six month on the same T&C subject to satisfactory performance of the contract as decided by this office.

(p) The bidder will furnish this unit the full particular of the candidate sponsored including details like name, father's name, age photograph, permanent address etc and also ensure that they possess the requisite academic/ technical qualifications and experience for rendering the requested to this unit.

(q) All the semi skilled chowkidar should have minimum three years of working experiences and specialization. Bidder is required to check and ensure the same. Certificate regarding skill test to be submitted by vendor.

(r) PSARA Certificate is mandatory.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to

exemption provided to such sellers under GeM GTC.

3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
