Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in the Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If a bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for per cent of 100% of total value.

4. For clearing of payment, firm has to upload GST, PAN details/Challan with invoice wise payment will be put on hold.

5. Payment Terms- Payment Terms 100% payment against Seller bill by Accountant through NEFT/RTGS only for accepted materials within 30 days from the date of receipt of material or submission of bills/document.

6. Ground Rent Clause: If the material supplied by the vendors is rejected at the premises, the vendors required to lift the rejected material within 30 days of issuance of I-Note. The factories under YIL have right to recover a charge for the storage @1% of the cost of material un-cleared, per week or part thereof, with maximum cap of 10% of value of the items. After lapse of 10 weeks, if it is found that firm has not taken any action for lifting of items, the goods may be confiscated and disposed off as per procedure in vogue after sending a notice and giving 30 working days' time to the vendor.
