If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. 2. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

(i) As per Service GCC 2018, para 2.6.1 Minimum Eligibility Criteria for Work experience are required: -

Work Experience: - The bidder should have satisfactorily Completed\* in the last three previous financial years and the current financial year upto the date of opening of the tender, one similar single service contract for a minimum of 35 % of advertised value of the bid. \* Completed service contract: - Include on-going service contract subject to payment of bills amounting to at least 35% of the advertised value of the bid. (ii) Minimum 02 Nos. of vehicle SUV category or higher version same category must be registered with the

name of the contractor itself or quoted firm name or MOU (Memorandum of Understanding) with the owner of the vehicle on stamp paper. Evidence of vehicle must be attached along with original bid otherwise offer will be rejected during technical evaluation.

(iii) Extra running kilometer per month is upto 500 KM if required. Payment for Extra running kilometer will be calculated as per the GeM SLA of additional KM running formula.

(iv) This vehicle will be running overall Jaipur division area, hence contractor shall be arranged road permit for vehicle for all over india.

(v) Contractor shall be fully responsible for any case i.e. repair, accident, loss, damage to the vehicle and driver.

(vi) The vehicle proposed to be offered on hire should be in good condition and also it should be registered in the name of tenderer, or the tenderer should have an MOU (Memorandum of Understanding) with the owner of the vehicle for the proposed hiring with Railway and the tenderer is required to submit the supporting documents at the time of provide the vehicle to consignee.

(ix) Latest General Conditions of Contract for Services of Indian Railway will be applicable and special condition of contract attached in bid ATC.

(x) Any defaulter/suspended firm in previous six months from date of publish of bid from this office also will be considered disqualified during technical evaluation.

(xii) Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).

(xiii) Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only

(xiv) While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

(xiv) The tenderer has to place of 03 (Three) no's Non AC SUV-Vehicle , **02 no's vehicles for the use of .Sr.DSO/JP, DSO/JP with separate drivers for 12 hrs/day and 01 vehicle round the clock (for 24 hrs) with 02 drivers** for safety inspections by safety officers/supervisors for 24 hrsx07days, total 03 no's vehicles for a period of 02 years.

(xv) Usages: 2500 kms x320 hrs, out stations 24x7 days, per month. for 02 years, total 03 no's vehicles ,i.e. 02 no's vehicles with drivers for 12 hrs/day and 01 vehicle with 02 drivers (separate driver for every 12 hrs shift) for round the clock, 24hrs x 07days, driver should be changed after 12 hrs duty.

(xvi). Working of Railways is 24x7 hrs, hence driver may be called at any time in emergent situation. Contractor must ensure availability of driver whenever they are called.

(xvii) **Necessary charges like running extra kms/hrs will be additionally calculated after completing of total kms for combined of all 03 vehicle's, For the purpose of extra payment on account of extra KMs running of the vehicle, total KMs. Runs combined by the all 03 vehicles**

for 3 months duration shall be considered. In case a vehicle is run for shorter KM. in one month and more in the next month, total KM will be clubbed. Such clubbing shall be done for combined of all 03 vehicles for 3 months period starting from the next month of the date of L.O.A. For example - if a vehicle is hired for stipulated 2500 KM per month, then additional payment for extra KM will be paid when total KM running combined of the 03 vehicles is more than  $2500 \times 3 = 7500$  KMs  $\times 03$  months = 22500 kms over a period of 3 months only. Counting of such 03 months period will be starting from the next month of date of L.O.A.

(xviii) Normally, the 02 no's of vehicles with drivers shall be available from 8.00 hrs. to 20.30 hrs. With 30 minutes lunch break during day or as decided by in charge as per requirement and on call during night after day shift or on off day also and 01 vehicle with 02 drivers shall be available for round the clock, 24hrs x 07days (separate driver for every 12hrs shift from 8.00 hrs. to 20.00 hrs and 20.00 hrs to 8.00hrs, driver shall be change after 12 hrs duty). The vehicle can be called for duty during any emergency works to check level crossing, surprise night inspections, derailment/accident of train during night/day etc. also timing of vehicles may be changed as per requirement of safety officers.

(xix) Driver should be resident of Jaipur city only and have live smart phone connection so that they are contactable whenever required.

(xx) One weekly off is permitted to the Driver. (After 6 day continuous working) One day weekly off on any nominated day of the week will be permitted to the driver, normally on Sunday, however the day of weekly off can be changed due to exigencies of work at the discretion of the officer of Safety department and the rest can be adjusted on any other day within that month, decided by officer in-charge. If rest cannot be adjusted then payment for the same shall not be made to the contractor.

One weekly off is also permitted to the drivers of round the clock inspection vehicle, but alternate drivers should be arranged by the contractor on drivers off day's. The one round the clock vehicle should be available 24 x 07 days for emergencies duties at safety office/JP, any extra payment for the same shall not be made to the contractor.

In the event where the distance travelled exceeds the monthly usage variant, amount will be paid for additional Kms as per schedule. However, the payment for the selected usage variant in a month will be paid every month." Further, the unused Kms in a particular month shall not be carried forward or adjusted beyond 6 months
