1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the

Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 10% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

6. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

1. **Online bids are invited from authorised dealers / OEM.** Acceptance of terms and conditions certificate should be uploaded along with this bid.
2. **Delivery period:** Delivery period for supply of items would be 45 days from date of placing Gem contract.
3. **Liquidated Damages:** If the stores are not supplied within the stipulated period /limit as specified a penalty of 0.50% per week or part thereof not exceeding 10% of the total cost of the Gem order will be levied for late supply at the discretion of Officer Commanding, 1053 Field Workshop as per LD clause.
4. **Piecemeal supply:** Piecemeal supply of item will not be acceptable. All items in a particular Gem Contract will be supplied in one Consignment.
5. **Consignee:** Officer Commanding, 1053 Field Workshop (GREF), C/O 56 APO, Srinagar.
6. **Accepting Authority:** Officer Commanding, 1053 Field Workshop (GREF), C/O 56 APO, Srinagar.

8. **Inspection of Stores:** Items supplied Cat 'A' spares to be checked by a Board of Officer detailed by Accepting Officer. The stores should be as per specification mentioned in Gem Contract. Stores will be provided for inspection within the delivery period by the concerned supplier.
9. **Rejected Stores:** All rejected stores are liable to be back loaded to the Supplier concerned by the Consignee/ collection agency at risk and cost of the supplier/ firm (in case stores not accepted by Board of Officers).

1. Acceptance of a quotation will be subject to the following terms and conditions:

a) All technical documents and declaration of firm duly signed and stamped by firm representative and same will be duly uploaded with bid. GST registration and NEFT mandate form/ cancelled cheque should be uploaded with bid.

b) Store will have to be dispatched to Officer Commanding, 1053 Field Workshop (GREF), Beacon complex, Rangreth, Srinagar (J&K).

c) GST will be paid as applicable and no other charges will be paid. No transportation charges applicable. transpo

d) Payment will be on receipt of stores in full depth and range in good condition within 30 days by the consignee. conditi

e) In case you are holding proprietary rights to the stores mentioned in the schedule certificate to the effect shall be endorsed in your quotation. sch

f) The items and quantities mentioned in the schedule are subject to variation and can be increases or decreased. In case of any dispute, the decision of the Officer Commanding, 1053 Field Workshop (GRE) will be final and binding in all respects.

g) Stores will be delivered within 45 days of placing the Supply Order if placed, or by the firm date mentioned therein.

h) The rates should be valid for three months from the date of opening of the quotation.

j) Quotations violating all or any of the conditions given above are liable for rejection without assigning any reason thereof. re

2. Liquidated damages: If contractor/seller fails in the performance of the contract within the time fixed under this contract or any other extension thereof, the contractor/seller shall be liable to pay as agreed liquidated damages and not as penalty a sum equivalent to ½ % (Half percentage) of the contract price of the items per week of such delay or part thereof. The supplier's liability for liquidated damages shall not exceed 10% (Ten percentages) of the items not delivered. Such damages shall be in full satisfaction of the contract/seller's liability for the delay. If the delivery is delayed beyond 10 weeks, the purchaser may at his own option can terminate the contract.

If any delay in supply arises from any cause which the purchaser may deem to be on reasonable ground such as wrong supplies or losses in transit from the main suppliers to the supplier or any cause beyond the control of supplier/seller such as strikes, lock outs, fire acts of god or other similar eventualities constituting the recognized 'FORCE MAJEURE' such additional time, as may be considered under the circumstances of the case by the purchaser, may be allowed by him, provided that an intimation of such circumstance is given by the supplier/seller to the purchaser not later than 10 days of their happenings.

7. **Disposal of unserviceable/incorrect items:** Incorrect and unserviceable items, if any, found by the inspecting Board of Officers shall be lifted by the supplier under own arrangements within a month of supply of the stores. In case supplier fails to lift the rejected/surplus within above specific time, consignee may dispose of the same by the discretion of firm's risk and cost.

8. **Guarantee/warranty:**

a) The period of warranty shall be 06 months from the date of acceptance of the stores.

b) The supplier will be responsible for free replacement of stores found defective within a period of 10 days from the date of intimation by the consignee.

9. Items of tender may be increased or decreased by CFA by 25 % of total value of tender.

10. **Extension of delivery period:** The purchaser reserves the right to cancel the supply order/balance quantity not supplied within the delivery period on risk and cost of the supplier. However, purchaser may grant extension of delivery period if same asked for by the firm within the delivery period subject to the following conditions:-

a) There are no changes in cost of supply order.

b) That the purchaser has the right to recover liquidate damages from contractor under the purchase of clause 3 of the contract for the stores which are not delivered within the delivery period.

11. Taxes applicable are clearly mentioned as separate rate quoted as percentage (%) against remarks column of all items otherwise same will not be accepted.

12. **Please acknowledge:** The receipt of acceptance of supply order to be sent within 07 days of placing of supply order failing which supply orders will be deemed as accepted by you.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses

on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider.
