7. 1- WHERE THERE IS CONFLICT BETWEEN GeM T&C AND OUR ORGANISATION T&C, LATTER(OUR T&C) SHALL PREVAIL.
8. 2-ALL DECLARATION SHOULD BE PROVIDED BY SELLER SHOULD BE ON NON JUDICIAL STAMP PAPER DULLY SELF ATTESTED BY THE BIDDER.
