8. BIDDER MUST UPLOAD AN UNDERTAKING STATING THE ACCEPTANCE OF ALL THE ADDITIONAL SPECIFICATION PARAMETERS OR TECHNICAL COMPLIANCE SHEET MENTIONING THE ACCEPTANCE OF ALL PARAMETERS INCLUDING ADDITIONAL SPECIFICATION PARAMETERS WITHOUT WHICH OFFERS WILL BE NOT BE CONSIDERED.
9. ALL THE DOCUMENTS UNDER BUYER ATC SHALL BE DULY FILLED, SIGNED & STAMPED AND UPLOADED ALONG WITH THE OFFER, FAILING WHICH THE OFFER WILL BE REJECTED.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
