1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

1. Consignee Instructions.

- a. Stores will be consigned on freight to pay basis after inspection by authorized representative and Board of Officers at consignee location.
- b. The rates quoted and accepted are for delivery of stores inside the premises of the consignee (price at destination) that is, unloading at the consignee's end will be arranged by the supplier for which no extra payment will be offered by the department.

2. Payment Instructions.

- a. Payment shall be made only on completion of the complete order as specified.
- b. Payment will be made only after the actual receipt of all the stores at destination only after inspection through a Board of Officers constituted by this HQ. No advance / part payments will be made.
- c. No extra payment will be made for items compulsory required for execution of work.
- d. Payment will be made through A/C payee cheque / RTGS / NEFT / ECS as feasible to the department.

3. Period of Completion. The items will be supplied on site within 15 days from the date of supply order issued.

4. Inspection Authority.

- a. The stores will be subject to inspection to ascertain that they conform to the specifications as laid down in the supply order by the following as marked:
- b. Inspection and acceptance of stores will be carried out by the authorized representative and Board of Officers at consignee office as convened by the Accepting Officer / DDO.

5. General Conditions. If the delivery of stores by the stipulated date is expected to be delayed due to any cause beyond your control, you shall immediately on the happening of the event causing delay in the supply of stores, give notice thereof in writing to the undersigned or Accepting Officer (AO) who after consideration of circumstances causing delay in the supply may / may not grant reasonable extension of time for delivery of stores as per requirement at a later stage. In case extension not been granted by Accepting Officer, the department is not responsible for the orders placed by supplier on OEMs / dealers / Distributors or any source for execution.

6. In case stores ordered on receipt are not found acceptable after inspection, the defective stores, will be removed and replaced by the store of correct specification by the supplier at his own expense. In case of any dispute decision of the Accepting Officer will be final and binding. In case the store supplied is found not conforming to the required specifications, the same either partly or fully will be rejected by the department at any stage. The supplier will have no claim whatsoever on account of rejection of his offer which is without any prejudice. In this regard, the decision of Accepting Officer will be final and binding.

7. No insurance charges will be paid by the department. The Consignees accepts no responsibility and no liability for the stores loss or damage to the stores in transit or for the rejected stores lying inside its premises for whatsoever reason. No extra charges will be paid towards installation of new equipment as the manufacturer guide lines.

8. The Accepting Officer/DDO reserves the right to subject the stores to a second inspection by an authority nominated by him or to inspect the stores himself, and may reject them if not found conforming to the laid down specifications, with a period of a months from the date of acceptance by the normal inspecting authority mentioned above even if the stores have been accepted, passed and paid for. The supplier shall replace such stores with the stores of correct specifications within a period of one month on receipt of due notice in writ

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
