1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price

within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

6. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or

contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

- 1. Security Deposit will be released after completion of shelf life of supplied items i.e. 18 months.
- 2. Performance Guarantee will be released after Six (06) months of completion of work.

**SHELF LIFE**

Minimum Shelf life in months from the date of manufacture will be 18 Months. and product will be replaced in accordance shelf life.

**CLAUSE OF SUPPLY**

Supply will be received twice in year i.e. on half yearly basis.

**CLAUSE OF WARRANTY CERTIFICATE**

Supplier must fully comply in all respect with the Technical specifications and conditions laid down in the rate contract and in accordance with the required standards.

Each supply should be accompanied with a "Warranty Certificate" duly signed by the tenderer as under:

The bidder/supplier hereby shall declare that the supply as detailed below sold to the purchaser under this contract shall be of the best quality and workmanship and shall be strictly in accordance with specification and particulars contained in the description clause hereof and the bidder hereby guarantees that the supply would continue to comply to the description and the quality aforesaid for a period of use for full life or minimum of five sixth (5/6th) or three fourth 3/4th as applicable for the particular item from the specified shelf life from the date of manufacture of the said supply to the purchaser Notwithstanding the above , the fact that the said stores fail to conform to the description and quality aforesaid and the purchaser will be entitled to reject the said supply or such part thereof as may be discovered not complying to the said description and quality. Losses due to premature deterioration due to any cause and activities during life potency will be replaced by the firm at its own cost at consignee's site within a period of forty five days or such further period as may be extended from time to time by the purchaser at his discretion and in such an event the above mentioned self life shall apply to the items replaced from the date of the replacement there of otherwise the seller shall pay to the purchaser as a compensation for such damage as may arise by reason of the breach of the conditions

Nothing herein contained shall prejudice any other rights of the purchaser in that behalf under this contract or otherwise.

If the supplier, having been notified fails to replace, within the period specified above, the purchaser may p

proceed to take such remedial action as may be necessary at the supplier's risk and expense and without prejudice, to other rights which the purchaser may have against the supplier under the rate contract.

**NOTE:** The tenderer shall furnish along with their quotations as well as in the every supply the above mentioned warranty separately.

The purchaser also reserves the right to disapprove or reject the items which are not in accordance with the samples supplied and approved by the Council. The rejected lot will be returned to the suppliers at their own cost and supplier will be bound to replace the same within a time specified in the communication and the rejected items shall be collected from Central Medical Store within 15 days from the date of replacement.

### **Life Period:**

The maximum period permitted between the date of manufacturing and the date supply of items to the stores are:-

- a) **For items having the shelf life of Two Years or less :** The supplied stock should not be older than one-fourth (1/4) of its shelf life from the date of manufacture i.e. not more than 1/4th of their life should have expired at the time of their delivery to the stores.

- b) **For items having shelf life more than Two years:** The supplied stock should not be older than one-sixth (1/6) of its shelf life from the date of manufacturing i.e. not more than 1/6th of their life should have expired at the time of their delivery to the stores.

However, Director, (Medical Services) reserves the right to grant extension in the shelf life of the medicine in case of genuine difficulty. The decision of Director, Medical Services shall be final and binding on the bidder.

In case of special situations where it is perceived in advance that the items supplied might not be consumed during its shelf life the bidder is bound to replace the stock with fresh stock within fifteen days of communication from the purchaser.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any

Category item bunched with it.

4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
