1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

2. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product

during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

3. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. The bidder will have to provide undertaking for a warranty period from the date of supply against any manufacturing defects, quality, faulty raw material, poor workmanship and the material would be replaced/repair by the firm on their expenses within 10 days on receipt of instructions from the department.
6. Average Turnover of last Three Years should be 30% of the bid .
7. All the documents will be self-attested by the Contractor/Bidder.
8. Transportation and Labor facility is not provided by the department.
9. The Financial bid will be opened only those bidders who will be found technically qualified for the work and fulfill the requirements of tender.
10. In case of any stage it is found that any information furnished by bidder is found false/incorrect, EMD will be forfeited and will be debarred.
11. The Work order will be issued to agency after taking necessary approval from the Competent Authority .
12. The Quantity of the material can be increased or decreased as per actual requirement of the department on same rates according to the norms of the Gem.
- 13 . Preference will be given to local bidder.
14. Department shall have right to reject the bid at any time at any stage without assigning any reason.
