If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service

provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

9. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Experience Certificate for the supply of the same to any Govt/ PSU/ any renowned private organisation along with Supply/ Purchase Order.

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

4. **Generic**

B. The bidder will be rejected on the following grounds:-

- a) The bidder shall quote the bids for the items in accordance with technical specifications as mentioned in the bid document. Any discrepancy will not be considered and such bids shall be treated as rejected OR
- b) If the sample is not approved by the hospital authorities due to issues related to material quality, functionality, patient safety, durability, or any other concerns beyond technical specifications OR
- c) Any bidder who has been declared defaulter with respect to supply of items in this hospital.
- d) The bidder fails to submit the sample and other relevant documents as mentioned in the bid

C. Bidder's Turnover & ITR Details:

- The bidder must have a minimum turnover of ₹65 Lakhs during the last three (03) financial years.
- Turnover must be certified by a Chartered Accountant (CA) with UDIN mentioned.
- Copy of Income Tax Return (ITR) of the bidder for the last financial year to be submitted.
- Latest Net worth certificate certified by a Chartered Accountant (CA) with UDIN mentioned.

D. The bidder must have minimum three (03) years' experience in the Government sector on gem for same or similar products (supporting documents to be submitted).

E. The supplies are required in four equal installments.

F. OEM Turnover - The OEM must have a total turnover of minimum ₹30 Lakh during the last three (03) financial years.

G. As per CVC guidelines, the OEM and Reseller should not participate in the tender simultaneously and in the case, both bids will be disqualified.

I. Exemption on qualification criteria will be provided as per the latest Government orders upon verification of suitable valid supportive documents submitted by the bidder.

II. All the self certificates asked in this tender should be provided in bidder's letterhead.

III. Bidders are requested to state the compliance of each specification whether the quoted item is complying with the technical specification as per technical compliance sheet. Technical bids with any non-compliance / false information / not giving any supportive document/brochures not containing the required details/not provided technical compliance sheet as per format will be disqualified at the technical evaluation stage.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent
