1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
5. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
6. Purchase preference to Micro and Small Enterprises (MSEs) from the State of Bid Inviting Authority: Purchase preference will be given to MSEs as Micro and Small Enterprises from the State of Bid Inviting Authority. If the bidder wants to avail the Purchase preference, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
8. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

9. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

These Terms and Conditions govern your participation as a bidder in any bid initiated on the Government e-Marketplace (GeM) platform by any department, organization, or Public Sector Undertaking (PSU) of the Government of Gujarat. By submitting a bid, you agree to be bound by these Terms, in addition to all applicable GeM policies, guidelines, statutory provisions, and specifically, the Gujarat State Procurement Policy 2024.

1. Earnest Money Deposit (EMD)

All bidders are mandatory to submit an Earnest Money Deposit (EMD) as per below detail.

(As per the Gujarat State Procurement Policy 2024).

The EMD must be in the form of a Demand Draft (DD).

The DD should clearly state the BID reference number and the bidder's name.

Uploading a Scanned Copy:

Bidders must upload a scanned copy of the DD to the GeM Portal. The scanned copy should be clear and legible, ensuring all details of the DD are visible.

The uploaded document will be considered as proof of EMD submission.

Physical Submission of DD:

In addition to uploading the scanned copy, bidders are required to submit the original physical copy of the DD. The physical DD must reach the designated office/address mentioned in the BID document no later than three (3) days from the bid end date.

Late Submission: Failure to submit the physical DD within the stipulated timeframe will result in disqualification from the bid process. The uploaded scanned copy will not be considered a valid substitute for the physical DD.

Rejection:

The EMD will be rejected if the details on the physical DD do not match the details on the uploaded scanned copy, or if the DD is not drawn in the specified format at or on the designated bank. Any discrepancies may lead to disqualification.

Refund:

EMDs of unsuccessful bidders will be returned as per the terms and conditions specified in the bid document.

Eligibility criteria for Exemption in EMD:

- a) Micro & small-scale enterprises which participate directly in tendering process for the product which they are manufacturing / service which they are providing and have Udyam registration for items / service under procurement and having Registration with CSPO or National Small Industries Corporation
- b) Startups which participate directly in tendering process for the product which they are manufacturing / service which they are providing and recognised by DPIIT under the Start-up India Program and has obtained Udyam registration & CSPO/NSIC registration as MSE
- c) Organization which has registration certificate for the manufacturing product of the tender, from Gujarat Khadi Gramodyog Board or Khadi and Village In

dustries Commission (K.V.I.C) or Commissioner of Cottage Industries.

- d) Board/Corporations/PSUs of the Central/State Government for their own manufactured items
- e) State Government recognized organizations like (i) organizations for blinds, dumb and deaf, disabled, mentally disabled persons; (ii) women's self-help group recognized by Gujarat Livelihood Promotion Company; which participate directly in tendering process for the product which they are manufacturing / service which /they are providing
- f) Sellers who have got their credentials verified through the process of Vendor Assessment by Vendor Assessment Agencies through GeM for the Primary Product/Primary Service for which Bid/RA floated on GeM.
- g) In keeping with GeM guidelines, OEM and service providers rendering services directly or by its own and having annual turnover of INR 500 Crore or more.
- h) In keeping with GeM guidelines, Sellers/Service Providers holding BIS license for the Primary Product Category whose credentials are validated through BIS database.

2. Turnover as per GeM Bid:

- This turnover will typically be calculated based on the last three completed financial years preceding the bid opening date, ending on 31st March of the previous financial year.
- Bidders must submit valid documentary evidence, such as audited financial statements or a certificate from a Chartered Accountant/Cost Accountant indicating turnover details for the relevant period, to substantiate their declared turnover.
- In cases where the bidder's constitution/incorporation date is less than three years, the average turnover for the completed financial years since constitution shall be considered.
- Exemption for MSEs and Startups (as per GeM and GSPP 2024): Micro and Small Enterprises (MSEs) as per latest MSME rules, and Startups recognized by DIPIT under the Startup India Program with Udyam registration, shall be exempted from the "Bidder Turnover" criteria, subject to meeting quality and t

technical specifications. Supporting documents proving eligibility for such exemptions must be uploaded with the bid.

3. Experience as per GeM Bid:

- Bidders must possess the requisite experience as explicitly outlined in the specific GeM bid document.
- This may include a requirement for successfully completing a certain number of similar projects or supply orders within a specified number of years.
- The bid document will detail the type, value, and period of experience required.
- Bidders shall provide copies of relevant contracts/work orders, completion certificates, and any other supporting documents as evidence of their experience.
- Exemption for MSEs and Startups (as per GeM and GSPP 2024): MSEs and Startups shall be exempted from the "Experience Criteria," provided they meet the quality and technical specifications of the bid. Supporting documents proving eligibility for such exemptions must be uploaded with the bid.

4. Registered Office Within State (Based on Gujarat Government GeM Policy 2024)

- Local Preference: As per the Gujarat State Procurement Policy 2024, preference may be given to bidders whose registered office or a functional full-time branch office is located within the State of Gujarat (specifically, Ahmedabad/Gandhinagar or as specified in the bid document).
- Bidders claiming this preference must provide valid documentary evidence (e.g., GST registration with Gujarat address, Udyam Registration, or a certificate from a competent authority) to prove their registered office/branch office location in Gujarat.
- The specific weightage or preference extended to bidders from Gujarat will be explicitly mentioned in the bid document and will be in accordance with the prevailing Gujarat State Procurement Policy 2024.

5. Site Survey Report:

- For bids where the nature of goods or services necessitates an understanding of the existing site conditions (e.g., installation, AMC, infrastructure projects), bidders shall be required to conduct a mandatory site survey.
- The detailed requirements for the site survey, including the scope, format of the report, and submission deadline, will be specified in the bid document.
- Bidders must submit a comprehensive Site Survey Report, duly signed by an authorized representative, as part of their technical bid. This report should demonstrate a clear understanding of the site, potential challenges, and proposed solutions.

Failure to conduct the site survey or submit a satisfactory report may lead to disqualification of the bid. The cost of the site survey shall be borne by the bidder.

Technical Specifications: Bidders must ensure that their offered goods/services strictly conform to the technical specifications and quality standards mentioned in the bid document. Deviations may lead to rejection.

अस्वीकरण/Disclaimer

15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of

Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the [सामान्य नियम और शर्तें/General Terms and Conditions](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
