1. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

A. This tender is being processed on Single (OES) Basis with approval of competent authority. Only the bid of M/s **M/S Jost's Engineering Company Limited**, ( OES) having tender specific authorization will be acceptable, other bids will be out rightly rejected.

B. PRICE BASIS: Rate shall remain FIRM throughout the contract period.

C. Price Disclosure clause: If any price component related to subject NIT in full or in part is exposed and found with its techno-commercial offers, the offer shall out rightly be rejected and will not be considered further.

D. PAYMENT TERMS FOR WORKS: 100% along with GST within 15 days from the date of completion of Work along with submission of calibration certificate validity of 1year and submission of bill.

E. PERIOD OF CONTRACT: 60 days from the date of issuance of order.

F. SERVICE TAX / GST: Service tax/GST is required to be paid extra then the same has to be mentioned clearly in the offer with specific percentage (%) presently applicable. If included, then quantum of service tax /GST along with its applicable percentage (%) also to be indicated clearly in the offer.

G. Safety: The party should strictly follow the prevailing safety norms of DVC regarding Projects and Works during execution of works. DVC will not be liable for any accidents or incidents resulting from any kind of unsafe acts.

H. Travelling expenses: Travelling expenses of the service engineer will be in the scope of bidder.

I. Fooding and Lodging: During the visit of vendor personnel at MTPS site, Fooding and lodging to be arranged by their own (in the bidder's scope). However, lodging may be provided on chargeable basis based on availability of room in Guest house.

K. LD CLAUSE: DVC reserves the right to recover a sum equivalent to 0.5% of the order value for delayed work for each week of delay or part therefore subject to maximum of 5% of the order as Liquidated Damage due to delay in completion of work attributable to the vendor.

L. Engineer In -Charge: - The Sr. Manager (CMC), MTPS or his representative/s is the controlling

officer.

M. OFFER VALIDITY Quotation must be kept valid for at least 90 days from the date of opening of the enquiry.

N. PAYMENT THROUGH RTGS/NEFT: All payments to you will be released through RTGS/NEFT only. You have to submit the requisite details as asked for payment.
