If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
2. 4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. **Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. **Buyer Added Bid Specific Scope Of Work(SOW)**

Text Clause(s)

1. **The second Party will provide the services of Data Entry Operator for execution of work as assigned by the first party for the period from the date of start of contract i.e. 16.04.2026 to 31.03.2027.**
2. **The Second party will maintain data in respect of the person every month and submit to the first party who will allocate work to him.**
3. **The second Party will maintain data in respect of attendance of personnel provided. The Personnel shall inform the supervisor concerned of his or her absence well in time.**
4. **The personnel's (Data Entry Operator) provided by the second party should not have any criminal case against him/her. The second party should make adequate enquires about the character and antecedent of personnel deployed and provide identity details like driving licenses, work experience, proof of residence and photograph etc and a certificate to the first party.**
5. **The second party shall withdraw for misconduct, incompetence, breach of confidence by such personnel on receipt of such request from first party.**
6. **The second party shall engage necessary Data Entry Operator as required by the first party and it shall be the duty of second party to pay their salary every month within ten days of each month.**
7. **The personnel deployed shall be employee of second party.**
8. **The first party shall pay the second party at rate as fixed by the DC Mandi HP/Govt of HP and EPF & ESI as per applicable rates in force. The contract is being executed at the prevalent rates as fixed by the DC Mandi HP/Govt of HP and EPF & ESI as per applicable rates and will be eligible for renewal in sync with the revision of rates by the said authorities in due course of time.**
9. **The first party shall also pay Services charges as per GEM rate to the second party.**
10. **The first party reserves the right to deduct appropriate sums of money from payments due in case of any loss or due to any break in terms of this contract.**
11. **If the performance of the second party is found to be dissatisfactory, the contract will be terminated. The contract will stand terminated the day letter for termination is issued and in case of any dispute the decision of first party will be binding.**
12. **The contract can be terminated by either party by giving one month notice in-advance the second party shall stand forfeited.**
13. **The second party shall ensure that the work allocated to Data Entry Operator is completed within the stipulated time.**
14. **The second party shall ensure that full confidentiality is maintained in respect of data of t**

he first party by the Data Entry Operator. Affirmation to this has to be given by him before he/she is allowed to work.

15. The payments shall be made on the basis of monthly bill submitted by the second party and it will be made through crossed cheque draft/RTGS/NEFT at the earliest depending on the availability of funds.
16. Tax charges by the Central /State government will be charged by the second party extra as applicable from time to time.
17. The first party will make all payments as per Income Tax Act/GST Act.
18. Any liability arising out of Municipal, State Govt. Labor laws, ESIC Act will be borne by the second party. The First party shall not be responsible for any such liability.
19. The staff so deployed shall not be treated as employee of first party.
20. The second party shall not transfer or sub contract the performance of services.
- 21.** The Second Party shall pay wages in respect of the personnel deployed under the contract strictly in accordance with the provisions of the Himachal Pradesh Minimum Wages Rules, 1978, as amended from time to time, and as per the rates notified by the Government of Himachal Pradesh from time to time.
22. The second party must have a registered office at Mandi, District Mandi, Himachal Pradesh and must provide proof of registered office by furnishing copy of registration certificate. Further preference shall be given to the personnel supplied being resident of Distt. Mandi and has minimum travelling time to reach the office, so that in case of need, such personnel can work till late or come early as may be needed during time barring periods etc.
- 23. The second party may have a minimum of 2 years of experience in providing manpower services to any Central Government Department offices within the territorial jurisdiction of District Mandi, HP.**
24. The contract can be extended up to a period of 6 months at a time for maximum period of 1 more year on account of administrative expediency subject to satisfactory performance of the services by the contractor.
25. Given the crucial nature of time-barring Government Official work being handled by the Purchaser party, the seller must ensure provisioning/deputing of the outsourced staff at the station who is competent in Microsoft Office/ handling data in .xlsx format, specific email replies based on directions, Analysis of Data, MIS handling, Letter drafting etc within 24 hours of successful execution of contract failing which the contract is liable to be terminated by the Purchaser without any further opportunity/show-cause.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The second party must have a registered office at Mandi, District Mandi, Himachal Pradesh and must provide proof of registered office by furnishing copy of registration certificate. Further preference shall be given to the personnel supplied being resident of Distt. Mandi and has minimum travelling time to reach the office, so that in case of need, such personnel can work till late or come early as may be needed during time barring periods etc.
2. The second party may have a minimum of 2 years of experience in providing manpower services to any Central Government Department offices within the territorial jurisdiction of District Mandi, HP.
3. EPF and ESIC Registration certificate

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
