Special terms and conditions-Version:1 effective from 06-12-2024 for category Waiting Area /

Airport Terminal / Public Place / Reception area Chair or Seat (V2)

1. 1. For chairs with charging unit / wiring provisions, such provisions are required to be detailed out by buyer.
2. "Color family" is indicative in nature and to be considered for representative purposes. Seller to select the closest representative color from the given options.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.
