1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

4. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

5. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

6. Warranty

Successful bidder will have to ensure that adequate number of dedicated technical service personals / engineers are designated / deployed for attending to the Service Request in a time bound manner and for ensuring Timely Servicing / rectification of defects during warranty period, as per Service level agreement indicated in the relevant clause of the bid.

7. **Warranty**

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

8. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

9. **Certificates**

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

10. **Certificates**

Material Test Certificate Should Be Sent Along with The Supply. The Material Will Be Checked by Buyer's Lab & the Results of the Lab will be the Sole Criteria for Acceptance of the Item.

11. **Certificates**

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

12. **Generic**

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

13. **Generic**

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

14. **Buyer Added Bid Specific ATC**

Bid Preparation and Submission Guidelines:

1. **Corrigendum Acknowledgment:**

Bidders must acknowledge any corrigenda related to the tender document before bid submission.

2. **Understanding Tender Requirements:**

Bidders are required to thoroughly review both the tender advertisement and the tender document to comprehend the specific documents required for submission. Deviations from the instructions may lead to bid rejection.

3. **Bid Document Preparation:**
 - Prepare all documents as per the tender schedule.
 - Documents should be scanned in black and white at 100 dpi and preferably submitted in PDF format.
 - Ensure that all documents meet the specified formats provided in the tender document.
4. **Standard Bid Preparation:**
 - Bids must be prepared as per the standard methodology provided.
 - Rates should be inclusive of all taxes and unconditional. Conditional submissions will lead to rejection.
 - Sellers should quote their rates on the GeM portal within the Financial Bid Envelope. Any mention of prices in the technical bid will result in rejection.
5. **No Conditional Offers:**

Conditional bids or quotations are not accepted. All terms, specifications, and supply conditions must strictly adhere to the tender document.
6. **Penalties and Liquidated Damages:**

Delays or non-compliance with tender terms may lead to penalties or liquidated damages, as specified in the tender.
7. **Bid Securing Declaration:**

Bidders must submit an undertaking for bid securing Declaration, confirming that any bid withdrawal, modification, failure to sign contracts, or non-submission of performance security within the stipulated time will lead to suspension for three (3) years from the disqualification date.
8. **Standard Time Reference:**

The server time displayed on the bidder's dashboard will be considered the reference time for bid submission and bid opening deadlines. Ensure strict adherence to these deadlines.
9. **Document Accessibility:**

Uploaded tender documents will only be accessible after tender opening by authorized officials.
10. **Bid Submission Confirmation:**

Upon successful bid submission, the portal will generate a bid submission confirmation message, displaying relevant details, including the bid number, submission time, and date. The seller must certify that the pricing provided during the technical stage is accurate and consistent. Any discrepancies, including providing a higher or lower price at subsequent stages compared to the certified technical stage pricing, will be subject to scrutiny. Such discrepancies may lead to disqualification or other actions as per the rules and regulations governing this tender process. Higher price / Lower pricing regarding certification provide in technical stage.
11. **Prescribed Formats:**

Bids must follow the formats provided. Any modifications or rewording will result in disqualification.
12. **Compliance and Timeliness:**
 - Incomplete tenders or tenders submitted after the deadline will not be considered.
 - Sellers must ensure that all product warranties and guarantees as spe

cified in the tender are provided.

Right to Reject Offers:

1. **Validity of Registration:**

If the bidder's registration validity for the quoted item has expired, their bid will be treated as unregistered unless renewal has been applied for within the registration period.

2. **Buyer's Rights:**

The Buyer reserves the right to accept or reject any or all tenders without providing reasons and to annul the selection process at any time without liability.

3. **Technical Bid Opening:**

Only the technical bid containing supporting documents will be opened first for consideration. The Buyer reserves the right to inspect the seller's premises before awarding the tender.

4. **Bid Scrutiny:**

Bid scrutiny is conducted once. The seller must provide all necessary documents and compliance in the technical bid stage in a single attempt.

5. **Conflict of Interest:**

The seller must submit an undertaking confirming no conflict of interest that could influence the bidding process.

6. **Gem Incident:**

The seller must provide a self-undertaking stating that they have no ongoing incidents or issues for any reason. Any false information provided by the seller will result in actions being taken against them in accordance with the Incident Management Policy of the GeM Portal.

Clarification on Tender Document:

1. **Amendment of Tender:**

The Buyer may modify the tender document by issuing addenda or amendments, which will be posted on the GeM portal. Sellers must ensure they review all amendments.

2. **Technical Representation:**

The Buyer may request design details or workflow post-technical representation. Qualified bidders will be those meeting the buyer's expectations.

3. **Bid Clarification Requests:**

The purchaser may request clarifications in writing if needed, with a specific response deadline.

4. **Cost Involvement:**

The bidder bears all costs related to bid preparation, demonstration, and presentation.

5. **Provision of Technical Assistance:**
Sellers must confirm their readiness to provide technical assistance and submit a warranty bond affidavit in the bid.
6. **Techno-commercial Bid Evaluation:**
The technical committee (TC) will evaluate the bids based on eligibility, technical, and commercial compliance with tender conditions.
7. **Eligibility Criteria:**
Bidders will be evaluated based on their financial, technical, and production capabilities. Unresponsive bids will not be considered.
8. **Technical Suitability:**
The TC will evaluate the technical compliance of the offered goods. Deviations will be assessed as minor or major based on their impact.
9. **Comparison of Tenders:**
Bids will be compared on the total cost, including taxes, duties, and delivery. Local content compliance (Class 1) must be ensured.
10. **Notarized Affidavit:**
The seller must provide a notarized affidavit confirming they have understood and accepted the tender requirements. Seller also submit declaration that a company has not been blacklisted or debarred for any reason.
11. **Signature Requirements:**
All tender documents must be signed at designated places, and any corrections must be initialed.
12. **Corrupt or Fraudulent Practices:** Any involvement in corrupt or fraudulent practices will result in disqualification. Sellers must provide a non-conviction affidavit in the bid.
13. **Quality Assurance:**
The purchaser reserves the right to inspect and test goods to confirm compliance with contract specifications. Seller need to provide detailed QAP plan in bid for technical assurance.
14. **Integrity Pact:**
Sellers and buyers must follow the integrity pact guidelines, ensuring transparency and fairness throughout the bidding process. Seller need to provide compliance certificate in technical bid stated clause.

15. **Termination for Insolvency:** If the supplier becomes insolvent, the purchaser reserves the right to terminate the contract without compensation.

16. **Force Majeure:** If a Force Majeure event occurs, the supplier must notify the Purchaser in writing within 21 days. The contract may be terminated if the Force Majeure event persists for over 60 days.

17. **Dispute Resolution:** Any disputes arising will be settled through mutual consultations, failing which arbitration as per the Indian Arbitration and Conciliation Act, 1996, will apply.

18. **Anti-Profiteering Certificate:** Sellers must provide an Anti-Profiteering Certificate under GST regulations.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:
