If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
  2. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.
  5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
    - i. If number of technically qualified bidders are only 2 or 3.
    - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

#### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

#### 2. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 3. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

**(1) Pre-Qualification Criteria:** PQC is applicable as enclosed along with technical specification (page-3). Please submit all documents along with your offer, required as per PQC.

**(2) Payment Term:** Payments shall be "100% after receipt and acceptance of Material in 90 for Non-MSME / in 45 days for Micro and Small Enterprises (MSEs) / in 60 days for Medium Enterprises (MED) as per BHEL, Bhopal norms subjected to on-line submission of bills (This is in supersession of 10 days time as provided in clause 12 of GeM GTC).

**(4) 'BHEL'** monogram in size of 50 mm x 50 mm as attached in buyer uploaded ATC documents (Annexure -A, page-5) to be printed in blue ink through the length at every 500 mm on 3D bags only (BHEL monogram is not to be printed on 2D bags).

**(5)** quantity variation of +/-1 % shall be acceptable.

**(6)** Test certificates is required along with supply.

**(7) Quantity split:** The total bid quantity shall be split between two (2) sellers in the ratio of 67% : 33%. The bidder evaluated as L1 (lowest bidder) shall be awarded the quantity in accordance with the above-mentioned splitting ratio.

For the balance quantity, the L1 rate (i.e., the lowest accepted rate) shall be counter-offered to the next higher quoting bidder(s) for price matching. Upon acceptance of the counter-offered rate, order placement s

hall be made on such bidder(s) for the respective quantity as per the defined splitting criteria.

In the event that any of the next higher quoting bidder(s) do not accept the counter-offer, the corresponding unallocated quantity shall be offered to subsequent higher quoting bidder(s) in order of ranking, subject to their acceptance of the L1 rate.
