**Description: Supply of spares and supervision of erection & commissioning of Flare stack**

**1) Payment term:** 100% Basic payment shall be made within the stipulated days as mentioned below from the date of completion of entire scope (i.e supply & Supervision of E & C) subject to acceptance at BHEL Energy system facility, Nacharam, Hyderabad-500076, against submission of GST-compliant Invoice.

GST will be reimbursed against submission of proof of payment of GST to govt. of India.

Type of bidder:

- A. For Micro & Small enterprises (MSEs) payment will be made within 45 days
- B. For Medium Enterprises will be made within 60 days
- C. Non MSMEs will be made within 90 days

However, GST Portion of Invoice shall be released only upon:

- i) Vendor declaring the Invoice in their GSTR-1.
- ii) Receipt of Goods and Tax Invoice by BHEL.
- iii) Confirmation of Payment of GST thereon by vendor on GSTN.

**2) Compliance on restrictions under Rule 144 (XI) of the GFR:** Submit the Annexure - A which is attached in buyer added bid specific ATC document.

**3) Conflict of Interest Clause:** Submit the Annexure - B which is attached in buyer added bid specific ATC document.

**4) Technical Specification:** Bidder shall submit compliance on attached BHEL Technical specification (Annexure-1) uploaded in Buyer Specification Document.

**5) Terms of Delivery :** Shall be Free On Road (FOR) BHEL Energy systems facility, C/o IICT pilot plant chemical complex, Road no 7, Nacharam Industrial Area, Nacharam, Hyderabad 500076.

**6)** Vendor has to submit this GeM bid document duly signed and stamped on all pages. By submitting signed GeM bid document it affirms that vendor has accepted to all the terms and conditions mentioned in this bid such as Payment terms, delivery period, Terms of Delivery, Breach of contract, Remedies and Termination etc.

**7)** Insurance, loading/unloading from vendor site to BHEL Energy systems facility, C/o IICT pilot plant chemical complex, Road no 7, Nacharam Industrial Area, Nacharam will be in vendor scope only. Vendor has to quote price(s) inclusive of GST, Transportation/Insurance, Loading/Unloading charges.

**8) Breach of contract, Remedies and Termination:** In case of breach of contract, wherever the value of security instruments like performance bank guarantee available with BHEL against the said contract is at least 10% of the contract value, the same be encashed. In case the value of the security instruments available is less than 10% of the contract value, the balance amount be recovered from other financial remedies (i.e. available bills of the contract or, retention amount, etc. with BHEL) or legal remedies be pursued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, etc., shall be applied as per provisions of the contract.

It is mandatory that tax invoices with a net amount (including taxes) exceeding Rs five (5) lakhs uploaded on the portal are digitally signed using a Class 3 Digital Signature Certificate (DSC) issued by a licensed Certifying Authority. Submission of invoice document in hard copy is allowed for invoices with a net amount (including taxes) equal to and upto Rs five (5) lakhs, in case they were not digitally signed and uploaded on the portal.

The material will not be accepted inside BHEL in absence of the above.

**14) Grievance Redressal Mechanism**

To promote transparency and ensure fair treatment of all bidders, a structured Grievance Redressal Mechanism is in place to address any concerns or issues arising during the tendering process or in subsequent business dealings with the company.

Suppliers/Contractors are requested to follow the below escalation process for grievance resolution:

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
