1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

3. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or

similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

4. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

3. Generic

The Bidder representative shall be allowed entry upon consignee premises for such visits, only upon the express conditions that the Bidder will release and indemnify the Buyer and Consignee against all liabilities arising out of such visit including death or injury, loss or damage to property, and any other loss, damage, costs, and expenses incurred as a result of such visit.

3. The Bidder shall not be entitled to hold any claim against Buyer for noncompliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bid.

7. **Scope of Supply**

Scope of supply (Bid price to include all cost components) : Supply Installation Testing Commissioning of Goods and Training of operators and providing Statutory Clearances required (if any)

8. **Warranty**

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 10 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG). Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imburse the cost of such service / rectification to the Buyer.

2. OEM/its authorized dealer/distributors of dealer are allowed to bid for this tender. Valid registration certificate and other documents to be uploaded in support of same.

3. In case the bidder is authorized by the OEM, the agency shall upload valid authorization certificate and other certificates. (OEM shall write on the Certificate that no authorization has been given to other agency)
4. Earnest Money @ 2% of Advertised cost by the bidder in shape of CDR/FDR/DD pledged in favour of Secretary/Chief Accounts Officer J&K Sports Council.
5. Copy of Pan Card.
6. GST Registration certificate.
7. GST Return .(Last 03 Months)
8. The Agency or its OEM shall upload an e-stamped undertaking **(bid number must be written)** stating therein that the Agency or Its OEM has not been blacklisted/debarred by any of the Central / State Govt. Departments / Govt. Institutions /PSUs/ SAI in last three years.
9. Average Annual turnover of the bidder in the last three financial years of at least 50% of Advertised cost and above is necessary to ensure quality of work.
10. The Bidder or its OEM (themselves or through re-sellers) should have supplied same or similar Category Products for 20% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / Sports Authority of India / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year.
11. The procurement of items/equipment's shall be made / completed in all respects within 30 days from the date of issuance of Letter of Intent / work order.
12. All technical documents including brochures / product images and literature (in colour) of all the items mentioned in BOQ specifying specification should be uploaded with the bid documents.
13. Other relevant documents/details, if any shall be uploaded.

All pages of the documents uploaded should be page numbered and indexed.

The OEM can provide only one authorization for this particular tender.

The authorization provided to more than one for this particular tender shall be considered the bidder as Null & void (treating the bidder/s as Non-Responsive).

a. FINANCIAL BID should contain:

1. Financial Bid which should be submitted online only in (BOQ) (in Indian rupee)

The tenders shall be opened by the J&K Sports Council on due date or any other subsequent convenient date. The Secretary, J&K Sports Council shall reserve the right to accept or reject any tender without assigning any reason thereof.

The rate quoted shall have validity for a period of one year and no conditional tenders shall be entertained.

The rates tendered should be written both in words and figures inclusive of all taxes/charges like GST, inland transportation charges, insurance loading unloading incidental costs till purchase site etc. No extra cost shall be paid. In case of variation of rates in words and figures, amount in word will be considered.

The successful tenderer shall not assign or sublet the contract or any part thereof to any other agency.

After supplies are made to the department, the items shall have to be got inspected/surveyed by the Committee constituted by the Sports Council and for quality assurance the items shall be inspected/ surveyed by the team of experts from third party agency prior to the acceptance. The inspection charges, on this account shall be borne by the supplier, if J&K Sports Council requires.

The bidder shall also submit Manufacturing quality Self Certification.

The successful tenderer shall supply the equipment's within a period of 30 days.

The successful tenderer shall have to furnish performance Security/EPG for the due performance of the contract in the shape of CDR/FDR from any recognized Bank equivalent to 3% of the total value of the contract pledged to the Secretary/Chief Accounts Officer J&K Sports Council and shall be released after completion of work. Security deposit @10% of the allotted cost deducted from the bill shall be released after expiry of warranty period of 01 year from the date of supply/handover and satisfactory performance report from the concerned authorities.

"The successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a Land border with India unless such contractor is registered with the Competent Authority" and undertaking shall be made mandatory to comply with the GFR 2017 vis- à-vis Rule 144 (xi).

If at any stage it comes in the knowledge of department that the bidder has submitted/uploaded any fake document, the contract of the defaulter bidder shall be terminated and the bidder shall be debarred for participation in the tenders of J&K Sports Council for five years and the EMD/ performance security shall be forfeited.

As soon as the acceptance of the tender is communicated to the successful tenderer approved by the J&K Sports Council and in case of back out or failing to abide by the terms of the contract or if any tenderer withdraws its tender, the security deposits and other deposits or claims if any with the department shall be forfeited besides further necessary action shall also be initiated against such defaulting tenderers as per standing rules and law in force in the J&K. Further, extra cost, if any involved by Allotting the contract to any other agency shall also be recovered from the defaulting tenderers.

Payment shall be initiated by the Secretary J&K Sports Council when the equipments are delivered, inspected, accepted, surveyed and found as per prescribed specifications mentioned in BOQ and properly brought on stock/records of the department. No advance payment will be made under any circumstances.

The rates offered should be quoted in figures as well as in words inclusive of all taxes like GST and other charges. Taxes/ charges not mentioned in the offers will not be allowed and admissible.

Any erasing/overwriting mutilation in the tender form will result in outright rejection of the tender.

Conditional and ambiguous tender will not be entertained.

The Secretary, Sports Council shall reserve the right to accept any tender not necessarily the lowest and reject any tender without assigning any reason thereof.

No conditional tender will be accepted and no other conditions except those mentioned in the terms and conditions will be entertained in the tender.

All legal proceedings if any arises, to be instituted by either party Council, shall have to be lodged in the Court situated in Jammu and Kashmir and not elsewhere.

The tenderer should sign the tender at each page and at the end in token of the acceptance of all the terms and conditions of the tender.

The rate accepted shall remain in force for one year from the date of placement of work order.

Tender should be accompanied invariably by clearance certificates from the concerned Sales Tax/Income Tax Authorities.

The contract or supply can be repudiated at any time if the contract is not carried out to the satisfactions of the department and additional cost will be borne by the firm besides the penalty.

Deviations from tender specification, if any shall be specifically stated in a separate list titled as "deviation from tender specifications".

Tenderers shall send their tenders complete/self-explanatory in all respects to avoid back references/enquiries. The price quoted by the tenderer should be inclusive of all Taxes (GST, Entry tax, Levies and road transportation charges etc.)

The tenderers shall indicate their account number allotted by income tax department in the tender.

Taxes whichever will be applicable under rules shall be deducted from the bills as per Govt. Rules.

All other terms and conditions shall remain, as are in vogue in J&K Govt. and J&K Sports Council.
