Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. OEM

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a

registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

3. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

1. The supplier/bidder shall ensure complete doorstep delivery of the material at the **consignee location** in the **Andaman & Nicobar Islands, i.e., Office of the Superintendent of Police, Mayabunder, North & Middle Andaman District.** The scope of delivery shall include transportation, loading, unloading, and proper stacking of the materials at the designated place. All costs towards transportation, loading, unloading, handling, and stacking shall be borne entirely by the supplier/bidder, and no extra charges shall be payable by the buyer on this account.”
2. The bidder should have **prior experience of supplying goods to remote / island / difficult locations.** At least two (02) completed Consignee Receipt & Acceptance Certificates (CRACs), issued through the GeM portal, shall be attached/uploaded with the bid as proof of such experience.
3. **Scope of Supply:** The bid is for supply of A4 and FS size uncoated white copier paper, suitable for high-speed photocopiers, laser printers and inkjet printers, as per specifications mentioned in the bid.
4. **Delivery Period:-** The entire quantity shall be delivered within the stipulated delivery period from the date of contract. No extension of delivery period shall be granted on account of logistics, transportation, sea/air connectivity or transshipment issues.
5. **Single-Consignment Supply:** The entire quantity of A4 and FS paper shall be supplied in one single consignment. Partial, staggered or multiple consignments shall not be accepted.
6. **Price Inclusiveness:-** The quoted price shall be inclusive of all applicable taxes, freight, insurance, handling, transshipment and incidental charges up to the final delivery point. No additional claim on any account shall be entertained.

- 7. Packaging & Protection:** Each ream shall be moisture-proof packed, and cartons shall be suitably reinforced to withstand sea transport, high humidity and rough handling. Any damage due to inadequate packing shall be at the supplier's risk and cost.
- 8. Replacement of Damaged Paper:** Any reams found wet, damaged, torn, warped, discoloured or unfit for use at the time of delivery or inspection shall be replaced by the supplier at their own cost within 7 days, without affecting the warranty or delivery obligations.
- 9. Quality & Acceptance:** Acceptance of A4 and FS paper shall be subject to physical verification by the purchase committee. The decision of the consignee regarding quality, condition and usability shall be final and binding.
- 10. Logistics Feasibility Declaration:-** The bidder shall submit a self-declaration confirming that they have assessed logistics feasibility for supply to Andaman & Nicobar Islands and shall be fully responsible for timely delivery without seeking any relaxation.
- 11. Past Performance Capability:** The bidder should have experience in supplying goods to remote / island / difficult locations during the last three years. Documentary proof may be sought, if required.
- 12. No Back-to-Back Supply:** Back-to-back or third-party supply without prior approval of the buyer shall not be permitted.
- 13. No Change of Delivery Location:-** Request for change of consignee location or delivery point after placement of order shall not be allowed.
- 14. Penalty & Risk Purchase:-** In case of delay or failure to supply as per terms, Liquidated Damages, cancellation of order and risk purchase shall be effected as per GeM and GFR provisions.
- 15. False Commitment Clause:** Any false commitment regarding delivery capability or logistics shall attract action as per GeM norms, including cancellation and debarment.

- 16.** The bidder shall submit a self-declaration confirming feasibility of delivery to Andaman & Nicobar Islands.
- 17.** The material shall be packed suitably for sea transport and high humidity conditions. Any damaged, wet or unusable paper shall be replaced at supplier's cost within 7 days.
- 18.** Partial supply or change of delivery point shall not be permitted. Acceptance shall be subject to consignee's physical verification and satisfaction.
- 19.** The Seller/bidder should enclose PAN card, GST Registration, AADHAR.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional

terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
