II. Serve snacks/ biscuits to the employees/guests as and when required. Requirement of biscuits/cookies - quantity & quality will be given by HR department. Bills of the same will be reimbursed on actual value on monthly basis.

III.

Serving Meals (Veg & Non-Veg) at designated area.

IV.

Provide tea and coffee to guests as and when required.

BL will provide a designated area for serving tea/meals.

• The Successful bidder will be required to submit an undertaking that all employees proposed to be engaged do not have any criminal case or police complaint against them anywhere in India after awarding of PO

•

BL reserves the right to interact with the staff and ask for the replacement of such staff if they are found u

nsuitable. New people should be suitably briefed to handle the operations.

•

The contractor must arrange for milk, tea, sugar, coffee & other consumables/ingredients for preparation as well as other equipment which is required to prepare and serve the consumables.

•

Induction cooktop, Cups, saucers, glasses, trays, thermos & other utensils and cleaning material which are required for the serving of tea, coffee & meals will be provided by the Contractor. LPG gas cylinder or any other fuel will not be allowed for cooking purposes inside the factory premises. Electricity cost for tea coffee preparation will be borne by BL.

•

Availability and usage of Hair Net, Hand Gloves, Face Mask by the deputed staff has to be ensured by successful bidder. [Cost to be reimbursed by BL]

•

UNIFORM: The successful bidder shall supply a minimum of 2 sets of formal uniform to their staff within 30 days of issue of PO and ensure that they are in their full uniform while on duty. None of the staff should be visible in vests / shorts or improper clothing or without shoes at any time.

The cost for uniform is to be borne by the successful bidder.

• The contractor will have to deploy personnel as per the requirement for the above tasks. A copy of Government photo identity proof of the personnel duly attested by the contractor should be submitted to the HR department.

•

The contractor shall keep stock of all raw materials like tea-powder, sugar, coffee etc. sufficient for a one-week period and milk shall be procured fresh every day. The contractor shall also maintain an adequate stock of condensed milk powder to meet any emergency after 06:00 pm, if required.

•

Proper washing/ cleaning & hygienic condition of all equipment, utensils & allotted space is to be ensured at all times. [Cost to be borne by Bidder]

•

The contractor will use the space provided only for the purpose of subject service and will not cater any item which is not mentioned in the terms above.

•The contractor shall be personally responsible for the conduct and behavior of his staff. Any loss or damage to the company's movable or immovable property shall be made good to the company by the contractor.

•

In case of unsatisfactory performance of the successful tenderer, failure to adhere to prescribed norms or behavior by the staff of the contractor, the company reserves its right to cancel the contract or to deduct such amounts as the company may deem reasonable due to the loss of goodwill, business, etc. from the security deposit/BG deposited by the successful bidder or the contract would be forthwith terminated.

CONTRACT PERIOD: The contract will be for a period of two years (24 MONTHS) from date of issuance of P O/LOI whichever is earlier.

BASIS OF SELECTION:

The selection of L1 bidder will be done on the basis of the Lowest Total Bid Value for entire contract basis subject to furnishing the documentary evidence as per clause 13 of this tender document.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:
