4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 5. 2. **Following technical specifications shall have to be complied with:**

- i. Process of manufacturing of the bins shall be Roto molding.
- ii. Both the wheel shall be made of Rubber.
- iii. Minimum weight of the bin including the lid & handle shall be 18 kgs. (minimum).
- iv. Screen printing on the bins shall have to be done by the bidder as prescribed by the KMC.
- v. Load carrying capacity of the bins shall be 96 kgs. (minimum exclusive self weight of the bin).

4. After become lowest bidder (L1), the bidder shall have to submit sample of the item.

5. **Additional Performance Security:** As per Municipal Commissioner's Circular No. 48 of 2018-19 dated 24.07.2018, **Additional Performance Security @ 10% of the tendered amount** shall be obtained from the successful bidder if the accepted bid value is 80% or less of the Estimate put to tender. The said Additional Performance Security shall have to be submitted in form of Bank Guarantee from any Scheduled Bank. In case of non-compliance of the above clause the EMD will be forfeited. The said Additional Performance Security will be refunded after successful completion of the work. No interest shall be payable on the said amount.

6. **Delivery Schedule:**

- a) The successful bidder shall have to be delivered the bins phase wise as mentioned in below:
 - i. In 1st phase, the successful bidder must be delivered about 2000 nos. bin within 60 days w.e.f. the date of communication of the work order to the bidder, through e-mail, post or other media, whichever is earlier.
 - ii. In 2nd phase, the successful bidder must be delivered about 2000 nos. bin within 30 days after 1st phase.

iii. In 3rd & final phase, the successful bidder must be delivered rest quantity i.e. 2000 nos. bin within 30 days after 2nd phase.

b) The successful bidder shall have to deliver the articles at places within the

Jurisdiction of Kolkata Municipal Corporation as decided by KMC.

13. Reference of conditions published on any external site or reference to external documents/clauses.
