2. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

- 2 **Bidder must have 50% minimum work experience for 3 financial years for the similar category within bid end date**
- 3 **Bidder must need to upload last 3 years turnover which contain minimum twice bid value certificate issued by CA.**
- 4 **The bidder must have to submit an undertaking in the form of an oath on Rs. 300/- stamp paper that they not been blacklisted/debarred by any state government/central Gov./PSU in last three years as on last date of bid submission.**
- 5 **Bidder must submit ATC duly signed by the competent authority of the bidder.**
- 6 **Bidder must upload duly signed copy of Registration Certificate of Provident Fund and ESIC Department.**
- 7 **Qualified Agency should ensure that the salary of the employee shall be paid within 5th day of the every month on regular basis.**
- 8 **Agency should ensure that following documents have to be submitted along with the Bill Only after that the further action of paying the bill will be taken.

- 9 **Bidder must have registered office in Gujarat and registered evidence must be uploaded with bid and bidder service centre also available in consignee state.**
 - 10 **In case of item delay supply from the bidder side, Dy.DDO (Dev.), Navsari have right to impose penalty for it and bidder must abide with this condition and they are not eligible for the refund of penalty amount.**
- 11 **For the any issue related to these bid, legal jurisdiction will be Navsari only.**

Condition to be followed by the Selected Agency

1. It shall be the responsibility of the Service provider to pay not less than per day fixed amount to the driver/employee to be provided under the contract as per the provision of the relevant laws and regulation. In addition to that as per the statutory provision as and when mentioned in the letter of the labour commissioners for minimum wage must be followed.

2. Ensure that the employee's age is more than 18 years.
3. As per the undertaking given by the agency hereunder It shall be the responsibility of the Agency to pay the amount of salary from its own fund by the 5th day of the month following the month of service through account pay cheque. Even if there is a delay in the payment of the agency due to administrative reason of the office the service payment of the employee made within the stipulated time frame. Otherwise 10% of the deposit value penalty charged by the Institution.
4. The employee has to be paid according to the number of days he was worked, and if employee was absent any day, the agency immediately make alternative arrangement.
5. The Bill of employee to be submitted by the agency by the 2nd day of the every month it will be the responsibility of the agency to submit the details and certificates regarding the present of the employee/drivers supplied in the Institutions/concerned office.
6. There will be all legal liability of the employee is lying with the agency only.
7. The agency shall be solely responsible for the termination of the employee service or the terms of the service
8. Agency should ensure that the employed staff should work as per government's rules and support.
9. The agency is bound to compensate all loss caused by the authority/ Institution by the reason of the negligence of the employee supplied by the agency.
10. Agency sent their employee after comply of all the verification like ADHAR, history of the employee, resume report, police investigation etc.
11. An authorised representatives shall be appointed by the agency to monitor daily attendance of the employee and alternate arrangement etc. and representatives contact number submitted to the institution.
12. Kindly ensure that the employee provided by the agency they shall not consume pan masala, guthka, smoking etc.
13. This agreement is non-transferable hence, agency shall not give sub contract to any other agency. Without prior permission taken from the competent authority of the District panchayat office.
14. The agreement period is for 12 month from the date of work order given by the authority. But if the new bid process delayed to unavoidable reason before the expiry of the contract period. The Office may be extend the contract for such time as may be deemed fit till the bidding process completed.
15. In case of necessity the office shall open on holiday the employee must present in the office.
16. In the any event of an accident related to concern employee, all type of compensation shall be the responsibility of the agency and any court matter relate expenses to be borne by the agency.
17. Agency shall comply with labour laws. And paid wages time to time amended by the labour commissioner office.
18. The security deposit shall be equal to 5% of the Bid Value to be submitted before the work order issued in the form of fixed deposit of any nationalised Bank in favour of
District Development Officer, Navsari.
19. The contract may be terminated immediately by the District Development Officer, Navsari in case of breach of any condition.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
