If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

4. **Service & Support**

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

5. **Service & Support**

6. **Service & Support**

7. **Certificates**

Brief Scope of AMC

- Carry out monthly preventive visit on each DG Set.
- Carry out B-check maintenance @ 500 Hours /6 months along with filters & lube oil.
- Check Engine safety controls, check for tripping of engine / alternator and alarms.
- Check connection of AMF panel & Power cable connection for tightness and healthiness.

- Checking battery lead connections of DC alternator and engine battery, Apply petroleum jelly.
- Check Specific gravity of battery electrolyte. Add distilled water for top up. Measure battery Voltage and charging of DG Starting battery.
- Checking connection on AMF panel & ensuring automation of DG Set.
- Check and replace the engine Lube Oil and radiator coolant.
- Check and clean the air cleaner filter in every visit & change if required.
- Check the fan belt tension, condition & Water pump pulley /bearing for play.
- Check the oil/ fuel /Water hoses for any cracks, leakage or sponginess.
- Cleanliness of DG set & inside canopy after completion of the all checks / activities.
- Conduct trial of DG set after every PM visit & Run set for half an hour. Observe and note down the parameters in service report.
