1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which

no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 50 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 50% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

4. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

1. The following documents should be submitted in the technical Bid/Offer:

1.1 Agency should submit Valid **OEM authorization Certificate/Reseller Certificate from Godrej** as a part of technical Bid.

1.2 The bidder should submit the duly signed copy of BEL specification/tender document/scope of work indicating that they have read, clearly understood & accepted the requirements.

1.3 Agency should submit **duly filled Supplier Compliance for Commercial Terms and Conditions in the Technical Bid.**

2. The total price shall be **FOR - BEL, Bangalore** as mentioned in the tender, clearly indicating the breakup of taxes, duties, packing, forwarding, Freight and Insurance charges Nothing as extra shall be payable or considered.

3. **TAX : Agencies are requested to mention Applicable GST percentage included in the offer.**

4. Payment terms:-

4.1 For MSME Vendors :-

90% payment will be made within 30 days from the date of supply & acceptance of items at BEL. Balance 10% will be made against submission of Bank guarantee for 5% of total order value (excluding GST) towards performance bank guarantee valid for warranty period subject to bank confirmation.

4.2 For Non - MSME Vendors : -

80% payment will be made within 30 days from the date of supply & acceptance of the items at BEL. Balance 20% will be made against submission of Bank guarantee for 5% of total order value (excluding GST) towards performance bank guarantee valid for warranty period subject to bank confirmation.

4.3 No advance Payment will be paid/entertained.

5. **Bank Guarantee (BG) :** The successful Bidder shall submit the Bank Guarantee for 5% of total order value (excluding GST) as per BEL format only. The validity of the BG shall be up to expiry of warranty period plus 3 Months claim period.

Note : If the agency fails/not able to submit the bank guarantee for 5% of total order value, then 5% of total order value excluding GST will be deducted from the bills submitted by agency as security deposit and same shall be released after completion of the warranty period with due certification by Engineer-In-Charge.

6. The validity of the bid shall be **ninety (90) days** from the closing date of tender.

7. **Inspection :** BEL Inspectors will inspect the item at BEL.

8. **Delivery Schedule:** - Delivery shall be made **within 45 Days** from the date of Contract Order

9. **Warranty** : 01 Year from the date of supply and acceptance.

10. **Price Validity** : The quotation must remain valid for a period of 90 days from the closing date of the bid.

15. BEL reserves the right to reject any or all the tenders without assigning any reasons

16. Concurrence for Standard terms and conditions (Inland Enquiry) is need to be submitted

17. **Supplier compliance format to be filled and signed with seal and to be attached in the techno commercial bid cover-1**

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document.
