#### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Payment

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

#### 3. Buyer Added Bid Specific Scope Of Work(SOW)

#### **SCOPE OF WORK UNDER THE PURVIEW OF THIS TENDER ENQUIRY**

##### **1) For Unskilled Personnel**

i. Working days for unskilled labour under the purview of this tender will be from Monday to Saturday every week. Sunday or any other notified Gazetted Holiday will be off for the staff. Although, in certain circumstances, the working personnel may be called for duty on Sunday by the CGST & Central Excise, Appeals-III on prior notice.

ii. The CGST & Central Excise, Appeals-III premises consisting of various offices of staff and cabins of officers have to be cleaned every day by sweeping the dust and by using mop along with cleaning agents and disinfectants once in a day before the commencement of the office hours.

iii. The washrooms/toilets in the office premises should be washed and cleaned with surface cleaner and also by disinfectants before the commencement of the office every day and as and when cleaning is required.

iv. All furniture in the office premises should be dusted every day and must be kept dust free. The glass doors in the buildings should be cleaned with good cleaning material every day.

v. The staircase, the lift lobby and the passage in all the floors will have to be cleaned before the commencement of the office with use of detergent and disinfectants every day before the Commencement of the office and as and when required.

vi. All the ceiling fans, window panes, doors, glass facings and partition walls of the cabins will have to be cleaned once a week.

vii. The cleaning materials such as soaps, detergents, disinfectants, naphthalene balls etc. and the materials used in the cleaning and housekeeping services such as brooms, buckets, mops, clothes, scoops, brushes, dust bins etc. will be supplied by CGST & Central Excise, Appeals-III. However, the service provider should ensure that the equipment is used carefully and in case of any breakage due to negligence, the cost of the same will be deducted from the payment.

#### 4. **Buyer Added Bid Specific ATC**

If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. **The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:**

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**

However in case if any condition specified in सामान्य नियम और शर्तें/General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।/In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
