The vendor shall prepare **4 Octonorm/Wooden Wall Cabins** (White Colour) having 2 Tables in each cabin. The size of cubical should be atleast 9x9 feet with atleast 5 feet height (of side walls), as shown in the images on next page. Tubelights/Lights should be installed in a way that sufficient light is available for Photography Purpose at each cubical.

2. The vendor shall erect the tent structure; perform necessary electrical connections of lights, coolers, fans and other electrical equipment supplied by the vendor, at least 2 days before the scheduled programme i.e. by 23/02/2026.

3. The vendor shall **use only ISI marked wires/cables properly fixed, with proper conduiting**. All wires shall pass through conduit pipes from main electric panel till end points. Main Electrical panel/distribution box shall be mounted with appropriate MCB switches. The vendor to comply with all safety standards as per NFPA guidelines. Vendor should have Electrical Licence (copy to be attached along with the bids).

4. The vendor shall quote their rates inclusive of all services mentioned above and including transportation costs.

5. Entire event must be comprehensively covered under an INSURANCE policy that include all potential risks associated with the setup and operation of tentage and related services at the cost of service provider. The service provider shall be liable and responsible in case of any untoward incidents such as fire, structure collapse, fatality, or any other mishap, including financial liability for damages or losses incurred. The service provider shall deploy sufficient number of Fire-Extinguishers in all the areas covered under the tentage services, in accordance with the NFPA norms. The tent fabric/structure shall meet the fire-propagation performance requirements outlined in NFPA Guidelines. An undertaking in compliance to this must be submitted along with the bids.

16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.
