Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. ### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be  $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$ , subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

**NOTE:- Bidder are requested to strictly follow following instruction before submitting the bid**

(a) Indigenous OEM/Manufacturer shall only be allowed to Participate in this tender enquiry.

**(b) Tender Qty may be split in the ratio of 60:40 at L-1 price between L1 & L2 vendors (As per para 4.11 of OFBPM'2018, depending upon TE participation as below : (a) 60:40 (provided at least three sources were issued tenders and have also quoted).**

(c) Please submit following documents at the time of bidding, failing which the bid of the firm shall be summarily rejected

- i. Compliance statement (as per attached format)
- ii. local content certificate
- iii. Non-disclosure certificate (as per attached format ANNEXURE-VII)
- iv. Experience criteria i.e. Past Supply order awarded to the firms.
- v. Declaration certificate that firm not blacklisted for any Government department/PSU.
- vi. Undertaking with respect to Compliance of Restrictions for Countries which share land border with India - as stipulated by Govt. of India.

(d) VENDORS REGISTRATION:

i. Firms which are not registered with Opto Electronics Factory or Sister Factories for tendered goods/service are requested to submit duly filed Vendor Registration Request Form (VRRF) for tendered items at the time of bidding, failing which the bid of the firm shall be summarily rejected. Vendor Registration Request Form (VRRF Form) is attached at the end of this document as annexure-z , which has to be used until online VRRF submission process is resumed on Vendor registration portal of IOL's website.

ii. If firms already registered with Opto Electronics Factory or other Sister Factories for Similar range of items, please submit Registration Certificate along with Bid.

(e) Special condition for issuing of Die:

(i) Supplier has to collect the Die from OLF within 15 days of issue of the supply order against the security deposit. If the die is not collected within due date the competent authority has right to issue show cause notice and grant additional period of 15 days to collect the dies else the competent authority may decide to take appropriate decision to cancel the supply order.

(ii) Supplier has the obligation to return the die to OLF after successful completion of supply order. The final payment will be released only after receipt of die in intact condition at OLF, Dehradun.

(f) Bidders must ensure to upload correct catalogue while participating in GeM bid. The GeM supply order is found to be placed for the catalogue uploaded by the bidders, but the evaluation of the bid is done for the item tendered by the buyer. Buyer would not be responsible for any anomaly in GeM SO due to upload of wrong catalogue by the seller and the GeM SO must be considered as placed for the item as specified by the Buyer in that corresponding schedule.

(g) Firm should submit material test certificate from NABL accredited Lab.

(h) Additional term and conditions – Check list of documents to be submitted along with supplies: i) Invoice (ii) WC/GC (iii) QCC (iv) MTC (if applicable)

(i) NOTE: EMD is applicable as per clause of 1.5 & 3.15 of T&C of TE. Bidders are requested to submit the EMD exemption certificate.

## अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the

case may be.

15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
